# Welcome and Introductions

# Minutes of the previous AGM held on 29th June 2018.

These were approved by committee members

### Matters arising from the minutes

There were no matters arising from the minutes of the last meeting that will not be addressed during the AGM.

### Chair's report

- The chair introduced her report by thanking Hallam Medical for their continued support to AAPE.
- AAPE UK continue to widen involvement and high level representation
  - All 4 countries within the UK have developed policies and professional standards and contributed towards development and implementation of frameworks for Advanced Practice
- AAPE UK continues to foster links with Health Care Professional Education Leads
- There is wider representation on the AAPE Committee now with Pip Clark as Co-opted representative for Midwifery/Neonates
- AAPE UK AHP and Pharmacist Survey (October 2018)
  - A snap shot of APs has informed AAPE UK that there are now AHPs/Pharmacists registered on AP courses. This will be repeated in 2020 to monitor trends across programmes.
- The Council of Deans Advanced Practice Steering Group continues to work with HEE to progress availability of ACP education and ACP Apprenticeship programmes.
- Advanced Practice Week (November 2018) was successful at highlighting AP across the UK AAPE were involved in organising and supporting events
- Social media Twitter activity continues to raise the profile of AAPE events; in addition, information is regularly updated on the AAPE UK website
- AAPE UK membership continues to increase
- AAPE UK representatives continue to present at regional, national, and international conferences, including those organised with the Council of Deans (and HEE).
  - September 2018, and also ran a workshop promoting International Affiliate Membership.
- AAPE UK continue to respond to consultations, e.g.: ICN NP/CNS Guideline (March 2019)
- AAPE continue to support scholarly activity for its members, a grant was given to Dr Julian Barrett for consultation research.
  - ♥ Opportunity is available to seek funding but dissemination of work outcomes is vital

Proposed amendments to the Constitution: Article 6 MEMBERSHIP:

- 1. Removal of clause 6.3.4 offering Associate Membership for stakeholders with a specific interest in ACP development; and all subsequent referral to Associate members
- 2. 6.3.6 The AAPE UK uses an email The AAPE UK uses an email mailing list to circulate information to AAPE UK members and others.

Removal of the following part from clause 6.3.6:

"In addition, other interested individuals or HEIs may also be included in the mailing list who are not AAPE UK members and who have not paid AAPE UK fees".

### Article 7 ORGANISATIONAL and GOVERNANCE:

3. Amendment to Clause 7.5: to increase term of office from current two years to:

"The term of office of members of the Committee shall be three years".

4. Amendment to Clause 7.6: Replace current content which says:

"Elections shall be held annually when 8 members of the committee will be replaced or re-elected on a rotational basis to ensure that no more than 50% of the committee change on any one occasion" with "Elections shall be held annually when 5-6 members of the committee will be replaced or re-elected on a rotational basis to ensure that no more than a third of the committee change on any one occasion. To avoid destabilisation of the committee, the Chair and Deputy Chair will not stand for re-election to the committee at the same time. Similarly the Secretary and Treasurer will not stand for re-election to the committee at the same time."

All proposed amendments were approved.
